2007 HIGHLIGHTS

We are pleased to present this summary of the Inter-American Dialogue's work in 2007.

This year, we welcomed Enrique Iglesias as the Latin America co-chair of the Dialogue's Board of Directors, and Enrique García, Jim Kolbe, and Tom Mackell joined the Board. In May, Enrique Iglesias, secretary general of the Ibero-American General Secretariat, hosted the Dialogue's Board in Madrid for its spring meeting, which was followed by a conference with European and other Latin American and U.S. leaders.

In 2007, Dialogue staff published a dozen articles and interviews in leading policy journals—*Great Decisions*, *Current History*, *The New Republic*, *Foreign Affairs Online*, and *National Journal*—which analyzed the policy choices facing the next U.S. president, what needs to be done to repair strained relations among the countries of the hemisphere, the rise of authoritarian tendencies in the region, and the lack of accountability in Latin American schools. They also published over 60 articles in newspapers, including *The Washington Post*, *Los Angeles Times*, *The Miami Herald*, *The New York Daily News*, *El Tiempo*, *Cambio*, and *O Estado de São Paulo*—on topics ranging from the prospects of a Colombia-U.S. FTA, social turbulence in Peru, threats to press freedom, U.S. Cuba policy, China and Taiwan's struggle for influence in the region, and the social and economic impact of remittances. Dialogue staff are regularly quoted by U.S., Latin American, and European newspapers and interviewed on television and radio.

The Dialogue's social policy program released the report, *Fair Growth: Economic Policies for Latin America's Poor and Middle Income Majority*, which presents a dozen "tools" meant to make life in Latin America more equitable for a majority of its people.

Other highlights of the year's activities include the 11th annual Corporación Andina de Fomento (CAF) conference, which reviewed hemispheric political and economic trends, and evolving U.S. relations with Latin America and the Caribbean. This was widely agreed to be the best CAF conference overall—with more than 300 participants and featuring such speakers as Guatemala vice president Eduardo Stein, seven U.S. Congress members, a number of current and former cabinet officials from Latin America, IDB president Luis Alberto Moreno, and our co-sponsors, CAF president Enrique García and OAS secretary general José Miguel Insulza.

In 2007, the Andean Working Group met twice—once in Washington and again in Bogotá, Colombia. The Dialogue's work on the Andean region analyzes the policy issues and choices confronting the region. Publications include a monograph on *Hugo Chávez: A Test for U.S. Policy* and an analysis of Latin America's drug problem in *Current History*, both by Michael Shifter, as well as Working Papers by Colombian governor Antonio Navarro Wolf on *Ending the Conflict with the FARC: Time for a New Course* and by Chilean political leader and analyst Genaro Arriagada on *Petropolitics in Latin America: A Review of Energy Policy and Regional Relations*.

In 2007, the Dialogue's Congressional Members Working Group hosted over 55 members of Congress in private discussions and public forums on Capitol Hill and other Dialogue events. Members met with President Alvaro Uribe, Vice President Francisco Santos, and Defense Minister Juan Manuel Santos to address U.S.-Colombia relations. Members also discussed education in Central America and the Dominican Republic with President Leonel Fernández; the role of the international community in Haiti's; U.S.-Cuba policy choices; aid programs in the region; U.S. immigration policy; press freedom in Latin America; remittance flows; issues facing the English-Speaking Caribbean; and the U.S. role in the region's social development.

The Dialogue's Trade Policy Group met to consider the expansion of Trade Adjustment Assistance; pending U.S. free trade agreements with Colombia, Peru, and Panama; and U.S. trade policy objectives in the hemisphere. In cooperation with the OAS, the Dialogue launched a project on democratic governance, which held two workshops this year—in Guatemala and the Dominican Republic. The Dialogue periodically holds informal press roundtables on Western Hemisphere relations and U.S. foreign policy in Latin America.

Also in 2007, with the Canadian Foundation for the Americas (FOCAL), the Dialogue co-sponsored a major conference on inter-American institutions, featuring remarks by IDB president Luis Alberto Moreno, OAS Secretary General José Miguel Insulza, and Trinidad's Summit of the Americas Coordinator Luis Alberto Rodriguez. Dialogue president Peter Hakim participated in the first meeting of the Special Advisory Group for the fifth Summit of the Americas in Port of Spain, Trinidad and Tobago.

The Dialogue's education reform program, PREAL, organized eight launches of its 2007 report card on education in Central America and the Dominican Republic, *A Lot to Do*. Dominican Republic President Leonel Fernández spoke with members of Congress at a special event on Capitol Hill launching the report card. PREAL also organized an international conference on educational accountability, a final workshop in its Central American Coaching program, and a series of events related to its work on child labor and the prevention of school violence.

Dialogue forums and publications on remittances continue to play a leading role in setting the policy agenda. *Making the Most of Family Remittances*, the second report of the Dialogue's Task Force on Remittances was released on Capitol Hill with remarks by Senators Menendez (D-NJ) and Norm Coleman (R-MN).

Our Corporate Program continued to expand in 2007, and now includes 135 member companies. The Dialogue launched the Miami Group on Western Hemisphere Affairs, a forum that regularly assembles the city's corporate and financial leadership to exchange ideas on issues affecting business and trade with U.S. and Latin American policymakers. The first meeting featured Mexican finance minister Agustín Carstens.

U.S. FOREIGN POLICY IN THE HEMISPHERE

Congressional Program

- The Congressional Members Working Group (CMWG) convened on November 13 for a dinner discussion on the flow of remittances to Latin America and implications for development in the region. Dinner hosts Reps. Luis Gutierrez (D-IL) and Chris Cannon (R-UT) and their colleagues Reps. Xavier Becerra (D-CA), Sam Farr (D-CA), and Rush Holt (D-NJ) met with Donald Terry, manager of the IDB's Multilateral Investment Fund, Manuel Orozco, director of the Remittances and Development Program at the Inter-American Dialogue, among others.
- Reps. Adam Schiff (D-CA), Mike Pence (R-IN), and Connie Mack (R-FL) hosted a CMWG dinner on October 23 to discuss the state of press freedom in Latin America. Guest speakers included Philip Bennett, the managing editor of *The Washington Post*; Enrique Santos Calderón, the editor of *El Tiempo*, a leading Colombian newspaper; and Mariclaire Acosta, former minister of human rights and democracy under President Fox of Mexico. Other members of Congress included Reps. Mary Bono (R-CA), Gregory Meeks (D-NY), Xavier Becerra (D-CA), Rush Holt (D-NJ), Jerry Weller (R-IN) and Michael McCaul (R-TX).
- Nine members of Congress met with Defense Minister Juan Manuel Santos of Colombia for a dinner discussion on U.S.-Colombia relations on October 17. In the context of the debate over the U.S.-Colombia free trade agreement, the meeting was convened in anticipation of a review and renewal of funding for Plan Colombia. Rep. Gregory Meeks (D-NY) hosted the session. Also participating from Congress were Senator Mel Martínez (R-FL) and Representatives Xavier Becerra (D-CA), Sam Farr (D-CA), Marcy Kaptur (D-OH), David Price (D-NC), Charlie Rangel (D-NY), Joe Wilson (R-SC) and Jerry Weller (R-IL).
- President Leonel Fernández of the Dominican Republic and Reps. Mike Honda (D-CA) and Jim Moran (D-VA) presented the findings and recommendations from the *Report Card on Education in Central America*

and the Dominican Republic: A Lot to Do, released by the Dialogue’s education program—the Partnership for Educational Revitalization in the Americas (PREAL) on September 19.

- Seven members of Congress participated in the Dialogue’s two-day Annual Conference on Trade and Investment in the Americas with the Andean Development Corporation (CAF) and the OAS on September 4 and 5. Rep. Rubén Hinojosa (D-TX) took part in the private luncheon on the current financial credit turmoil. Representatives Nita Lowey (D-NY), Xavier Becerra (D-CA) and Henry Cuellar (D-TX) spoke on the first panel of the session on the US Agenda in Latin America. The second panel—which focused on trade policy—included Reps. Gregory Meeks (D-NY) and Jim Matheson (D-UT). Rep. Eliot Engel (D-NY) spoke on the Energy Cooperation and Policy panel.
- Senators Bob Menéndez (D-NJ) and Norm Coleman (R-IN) hosted a members-only dinner on U.S. aid programs in Latin America on July 17. Senior representatives from the U.S. Department of State, USAID, the Millennium Challenges Corporation,

the Inter-American Foundation, the Inter-American Development Bank, and the Center for Global Development discussed the objectives and effectiveness of current aid programs to the region and how U.S. aid funds might be best utilized. Representatives Earl Blumenauer (D-OR), Phil English (R-PA), Sam Farr (D-CA), Gregory Meeks (D-NY), Albio Sires (D-NJ), and Jerry Weller (R-IL) joined the session. The meeting was co-sponsored by the Inter-American Foundation.

- Immigration policy and hemispheric migration were the focus of a June 26th dinner discussion hosted by Representatives Howard Berman (D-CA) and Chris Cannon (R-UT). Reps. Xavier Becerra (D-CA), Yvette Clarke (D-NY), Bob Filner (D-CA), Gene Green (D-TX), Luis Gutiérrez (D-IL), Rush Holt (D-NJ), Nita Lowey (D-NY), John Tierney (D-MA), and Diane Watson (D-CA) exchanged views on the Senate’s immigration bill, the Border Security and Immigration Reform Act of 2007 (S.300). Also participating were Doris Meissner of the Migration Policy Institute, Ambassadors Arturo Sarukhan of Mexico and Rene Leon of El Salvador, Carlos Iturregui of the U.S. Citizenship

& Immigration Service, Stewart Baker of the U.S. Customs & Border Protection, Robert McCutcheon of the State Department, Larry Palmer of the Inter-American Foundation, among others.

- Just one week before heads of state and foreign ministers from the Caribbean Community (CARICOM) visited Washington for *The Conference on the Caribbean: A 20/20 Vision*, the Dialogue's Congressional Members Working Group met with several ambassadors from Caribbean countries for a dinner discussion on June 13 regarding issues facing the English-speaking Caribbean and Washington's ability to respond to these challenges. The dinner was hosted by Reps. Gregory Meeks (D-NY) and Jerry Weller (R-IL). Participating members were Donna Christensen (D-VI), Yvette Clark (D-NY), William Delahunt (D-MA), Sheila Jackson Lee (D-TX), Barbara Lee (D-CA), and Dianne Watson (D-MI). Other guests included Ambassadors Michael King of Barbados, Gordon Shirley of Jamaica, and Izben Williams of St. Kitts & Nevis, Daniel Fisk of the National Security Council, Brian Nichols of the State Department, and Albert Ramdin, assistant secretary general of the OAS.
- Colombian President Álvaro Uribe met with sixteen members of Congress on May 2 at a CMWG dinner hosted by Senators Ken Salazar (D-CO) and Mel Martinez (R-FL) and Representatives Dan Burton (R-IN) and Eliot Engel (D-NY). Participating members included Senator Bob Corker (R-TN) and Reps. Xavier Becerra (D-CA), William Delahunt (D-MA), Sam Farr (D-CA), Sander Levin (D-MI), Michael McCaul (R-TX), Gregory Meeks (D-NY), Donald Payne (D-IL), Albio Sires (D-NJ), Mark Souder (R-IN), Jerry Weller (R-IL), Joe Wilson (R-SC) and Frank Wolf (R-VA).
- The Dialogue sponsored a session on Capitol Hill with Senator Bob Menendez (D-NJ) on March 21. He spoke about the role of the United States in Latin America's social development, highlighting his legislation for a proposed "Economic Development and Social Investment Fund for the Americas Act."
- Michael Shifter, the Dialogue's vice president for policy, met with the Congressional Members Working Group on March 13 to discuss the highlights of his recently-published report, *Hugo Chávez: A Test for U.S. Policy*, and reflect

on the outcomes of President Bush's recent trip to Latin America. Reps. Eliot Engel (D-NY) and Dan Burton (R-IN) co-hosted and Reps. Xavier Becerra (D-CA) and William Delahunt (D-MA) joined the session. Shifter briefed congressional staff on the same issues the day before.

- Ten members of Congress met with Colombian Vice President Francisco Santos on February 13 to discuss congressional approval of the U.S.-

Colombia free trade agreement and the renewal of Plan Colombia. Reps. Nita Lowey (D-NY) and Jerry Weller (R-IL) co-hosted the dinner. Other congressional member participants were Reps. William Delahunt (D-MA), Sam Farr (D-CA), Doug Lamborn (R-CO), Sheila Jackson Lee (D-TX), Sander Levin (D-MI), Gregory Meeks (D-NY), Jean Schmidt (R-OH) and Mark Souder (R-IN).

- Reps. Eliot Engel (D-NY) and Jerry Weller (R-IL) hosted a Congressional

Members Working Group Dinner on January 30 to discuss the role the United States and the international community will play in the future of Haiti's development with Ambassador Edmond Mulet, the director of the UN Stabilization Mission in Haiti (MINUSTAH), OAS Secretary General José Miguel Insulza, and other representatives from the Haitian, international and development community. Ten other members participated, including Reps. Xavier Becerra (D-CA), Phil English (R-PA), Jim Gerlach (R-PA), Nita Lowey (D-NY), Gregory Meeks (D-NY), David Price (D-NC), Charles Rangel (D-NY), Jan Schakowsky (D-IL), Dianne Watson (D-CA), and Lynn Woolsey (D-CA).

- Rep. Jeff Flake (R-AZ) and William Delahunt (D-MA) spoke about U.S.-Cuba policy choices at an Inter-American Dialogue event on Capitol Hill on January 23. The two congressmen are lead proponents of easing trade and travel restrictions to Cuba. Last December, Flake and Delahunt led the first congressional visit to Cuba since Fidel Castro fell ill in July and his brother Raúl assumed power—and the largest to the island since the Cuban Revolution in 1959.

- The Inter-American Dialogue, Inter-American Development Bank, League of Women Voters, Inter-American Foundation, and Organization of American States convened in Washington a small group of women political leaders from Latin America and the Caribbean on March 28 to discuss the dramatic advances achieved by women seeking public office in the past ten years—and the special challenges currently facing women in electoral politics. U.S. Reps. Hilda Solis (D-CA) and Jerry Weller (R-IL) joined the discussions that were held at the Library of Congress and the Inter-American Development Bank.

- On January 18, the Dialogue focused congressional attention on press freedom in Latin America and the Caribbean. The session on Capitol Hill was hosted by Sen. Christopher Dodd (D-CT) and Reps. Adam Schiff (D-CA), Sam Farr (D-CA), Sheila Jackson Lee (D-TX), Mike Pence (R-IN), and Thomas Petri (R-WI). Discussions were led by Colombian journalist Daniel Coronell, at the time in exile at the University of California, Berkeley; Gonzalo Marroquin, president of the Inter American Press Association; Ignacio Alvarez, OAS; Karin Karlekar, Freedom House; Carlos Lauria, Committee to Protect Journalists; and Ricardo Trotti, Inter American Press Association.
- On October 29, Viji Rangaswami, Democratic trade counsel for the House Committee on Ways and Means, and Angela Ellard, minority staff director at the House Committee on Ways and Means, spoke to the Dialogue's Trade Policy Group about the potential expansion of Trade Adjustment Assistance (TAA), a federal program that provides aid and employment retraining assistance to workers who have lost their jobs because of trade.
- Angela Ellard, minority staff director at the House Committee on Ways and

Means, and Sophia King, then-legislative director for Representative Gregory Meeks (D-NY), met with the Dialogue's trade policy group on March 9. They discussed the direction of the U.S. trade agenda in the hemisphere. Participants weighed in on a variety of issues including free trade agreements with Colombia, Peru, and Panama, Andean trade preferences, and the expiration of the president's Trade Promotion Authority.

- Tim Reif, Democratic staff director for the Trade Subcommittee of the House Committee on Ways and Means, spoke on February 22 at the Dialogue's first trade policy group meeting of the year on the U.S. trade agenda in the Americas.

Europe & Latin America

- Hosted by Enrique Iglesias, secretary general of the Ibero-American General Secretariat (SEGIB) and the Dialogue’s new co-vice chair, the Inter-American Dialogue’s Board of Directors held its spring meeting in Madrid, followed by a conference with European, Latin American, and U.S. leaders, on May 17 and 18, 2007. Trade Policy Group

- The Dialogue's Trade Policy Group met on October 29 to discuss the expansion of Trade Adjustment Assistance (TAA), a federal program that provides aid and employment retraining assistance to workers who have lost their jobs because of trade. Featured guests included Howard Rosen, executive director of the Trade Adjustment Assistance Coalition, Viji Rangaswami, Democratic trade counsel for the House Committee on

Ways and Means, Barbara Somson, deputy director of legislative affairs at the United Auto Workers, and Angela Ellard, minority staff director at the House Committee on Ways and Means.

- Members of the Inter-American Dialogue's Trade Policy Group met at the Dialogue on March 9 with Angela Ellard, minority staff director at the House Committee on Ways and Means, and Sophia King, legislative director for Representative Gregory Meeks (D-NY), a prominent advocate for engaging the hemisphere through trade. They discussed the direction of the U.S. trade agenda in the hemisphere. Participants weighed in on a variety of issues including free trade agreements with Colombia, Peru, and Panama, Andean trade preferences, and the expiration of the president's Trade Promotion Authority.
- The Dialogue's Trade Policy Group gathered on February 22 to discuss what might be accomplished in 2007 toward achieving U.S. trade policy objectives in the hemisphere. The discussion

featured Tim Reif, Democratic staff director for the Trade Subcommittee of the House Committee on Ways & Means; Everett Eissenstat, assistant U.S. trade representative for the Americas; Sandra Polaski, director of the Trade, Equity and Development Project at the Carnegie Endowment for International Peace; and Sidney Weintraub, who holds the William E. Simon Chair in Political Economy at the Center for Strategic and International Affairs.

- Colombia's minister of defense, Juan Manuel Santos headlined an October 18 discussion on his country's evolving relations with the United States. He spoke of the U.S. Congress' failure to ratify the free trade agreement with Colombia despite security gains under Plan Colombia.

- Luis Oganés of JP Morgan Chase, Anoop Singh of International Monetary

Fund, and John Williamson of Peterson Institute were featured speakers on September 13 at the discussion, Global Market Turmoil: What Will It Mean for Latin America?

- William Maloney and Guillermo Perry, two authors of the recent World Bank publication, *Informality: Exit and Exclusion in Latin America and the Caribbean*, discussed the causes and effects of the informal job market in Latin America at a September 7 Dialogue meeting. Nancy Birdsall, Center for Global Development, and Nora Lustig, George Washington University, commented.
- Considered by many to be the father of the Chicago Boys, Arnold Harberger, currently professor of economics at UCLA and chief economic advisor at USAID, spoke on a range of economic issues in the region at the Center for Global Development on August 10, with Dialogue president Peter Hakim and Peterson Institute for International Economics senior fellow John Williamson providing commentary.

about their perspectives on politics, security, and trade in their country. The cabinet members were Fernando Bustamante, minister of internal and external security policy coordination, and Mauricio Dávalos, minister of economic and production policy coordination.

- Colombian President Álvaro Uribe met with sixteen members of Congress on May 2 at a CMWG dinner hosted by Senators Ken Salazar (D-CO) and Mel Martinez (R-FL) and Representatives Dan Burton (R-IN) and Eliot Engel (D-NY). Participating members included Senator Bob Corker (R-TN) and Reps. - Beatriz Nofal, president of Argentina's newly established National Investment Promotion Agency (ANDI), led a discussion on the state of the Argentine economy and prospects for investment, on February 28 at the Dialogue.

REMITTANCES & DEVELOPMENT

- The Congressional Members Working Group convened on November 13 for a dinner discussion on the flow of remittances to Latin America and implications for development in the region. Dinner hosts Reps. Luis Gutierrez (D-IL) and Chris Cannon (R-UT) and their colleagues Reps. Xavier Becerra (D-CA), Sam Farr (D-CA), and Rush Holt (D-NJ) met with Donald Terry, manager of the IDB’s Multilateral Investment Fund, Manuel Orozco, director of the Remittances and Development Program at the Inter-American Dialogue, among others.
- A small group of government officials and senior executives of money transfer companies and banking institutions met on September 19 to discuss the impact of remittances on the region, new data on migrants, and competition in the industry. Participants focused on the consolidation of money transfer companies, the rapid diversification of the marketplace, and continuing price declines in most corridors, driven mainly by greater competitiveness. They also discussed evolving patterns of remittance flows to Latin America, new and emerging challenges to remittance transfers, and the potential for U.S. policy to effectively engage the region’s long-neglected social agenda. The goal was to exchange ideas about what changes in U.S. policy would be most helpful in facilitating growth of the transfer industry, making remittance transfers more relevant to development and growth in Latin America.
- *Making the Most of Family Remittances*, A Report of the Inter-American Dialogue’s Task Force on Remittances, was released on May 1 on Capitol Hill. Senators Bob Menendez (D-NJ) and Norm Coleman (R-MN) hosted the event, which featured the Dialogue’s Manuel Orozco; Maria

Eugenia Brizuela de Avila, president of Banco Salvadoreño and former minister of foreign affairs of El Salvador; Earl Jarrett, president of the Jamaica National Building Society; and Donald Terry, manager of the Multilateral Investment Fund of the Inter-American Development Bank. This second Task Force report examines the high cost of transactions, financial sector opportunities to incorporate senders and receivers, and the macroeconomic effects of remittances. The authors recommend increasing the transparency of transfer fees, looking more closely at new technologies, and strengthening the relationship between money transfer operators and banking institutions.

- On March 14, 2007, the Dialogue brought together analysts and policy officials from U.S. and Latin American government agencies, private foundations, banks and other financial institutions, and international organizations to review current research priorities on remittances, discuss the main policy challenges regarding remittance flows, and identify new research and data needed to address the policy challenges.

Dialogues on Democracy

The Inter-American Dialogue in cooperation with the Organization of American States has launched a project, National Dialogues on Democracy, which involves conducting well-prepared, two-day workshops in eight Latin American countries with 25 to 30 top-ranked and well-known politicians, entrepreneurs, journalists, and political analysts. The workshops are being held in Argentina, Bolivia, Brazil, Chile, Colombia, Dominican Republic, Guatemala, and Mexico. After each workshop, the Dialogue will publish a report that synthesizes the deliberations and provides benchmarks for future progress on democratic consolidation.

- The first workshop—Guatemala: Ten Years after the Agreements on a Firm and Lasting Peace—took place in Antigua, Guatemala from March 22 to 24, 2007. Participants included Vice President Eduardo Stein, Congresswoman Nineth Montenegro, Vice Minister of Foreign Relations Marta Altolaguirre, Bishop of San Marcos Alvaro Ramazzini, as well as Gustavo Porras, Raquel Zelaya, and Richard Aitkenhead, all signers of the 1996 Peace Accords. Press Freedom

- Violence, Democracy, and Press Freedom in Mexico and Colombia was the topic of an October 23rd discussion at the Dialogue led by Enrique Santos Calderón, the editor of *El Tiempo* (Colombia), and Mariclaire Acosta, the Organization of American States.

Women's Leadership

EDUCATION POLICY

PREAL—Partnership for Educational Revitalization in the Americas

Report Cards

- From May to September 2007, PREAL organized eight launches of its 2007 report card on education in Central America and the Dominican Republic: *A Lot to Do (Mucho por Hacer)*. The launches took place in the Dominican Republic, El Salvador, Guatemala, Panama, and Honduras. President Leonel Fernández of the Dominican Republic, along with Representative Mike Honda (D-CA) and Representative Jim Moran (D-VA) spoke at a special event on Capitol Hill in Washington, DC, which capped these launches. Bolstered by extensive media coverage, the launches—which involved some 800 participants—emphasized that Central America needs to dramatically improve the quality and equity of its public schools.
- PREAL's partner in the Dominican Republic, FLACSO-DR, presented *Taking Stock (Pasando Balance)*, the 2006 PREAL Report Card on Education Progress in the Dominican Republic, to members of the bicameral congressional education committee on February 8th. The event was co-sponsored by the Dominican Socio-educational Forum (*Foro Socio-educativo Dominicano*), a network of six institutions dedicated to public debate of education policy and reform in the country.
- El Salvador's minister of education helped PREAL partners Centro Alfa and FEPADE launch the country's second education report card—*Building the Future (Construyendo el Futuro)*—on January 18th in San Salvador. PREAL's co-director presented PREAL's 2006 Report Card on Education in Latin America, *Quantity Without Quality (Cantidad sin Calidad)*, at the same event. During the proceedings, the minister of education presented PREAL with a bronze statue of Don Quixote, in recognition of its 10 years of support for education reform in El Salvador. Approximately 80 government officials, business leaders, and media representatives attended the event.

Working Group on Standards and Assessments (GTEE)

- On August 30th, the Working Group on Standards and Assessments held a workshop on education standards in Latin America in Tegucigalpa, Honduras. The event was organized in collaboration with the Honduran Ministry of Education, USAID, and PREAI's national partner, the Foundation for Education Ricardo Ernesto Maduro Andreu (FEREMA). Speakers included the recently appointed vice-secretary of education in Honduras.
- The GTEE—in collaboration with UNCEP and Circulo Empresarial, and with the support of the Ministry of Education of Panama—held a seminar on “Standards: An Opportunity to Improve Learning” in Panama City on August 15th. Participants included the Panamanian vice minister of education; the president of the National Council for Education; the rector of the University of Panama; and members of the Private Sector Council for Educational Assistance (CoSPA).

- At the request of the National Education Council and the Ministry of Economy and Finance of Peru, GTEE co-organized a discussion on the use of standards and assessments in the United States. The discussion took place July 11th and featured an expert on standards from the School of Education at the University of Miami.

Working Group on Teacher Professionalization (GTD)

- On November 20th, the Working Group on Teacher Professionalization and the Share Foundation (*Fundación Compartir*) co-hosted the seminar “Conceptualizing Professional Teaching Effectiveness,” which took place in Bogotá, Colombia.
- The GTD held the seminar “The Teaching Profession and Prospects for Continuous Professional Development” in Tegucigalpa, Honduras on November 6th. PREAI's national partner FEREMA and the Francisco Morazán National Teachers University (UPNFM) co-organized the event. Over 80

people attended the seminar, including professors from Honduran Teachers' colleges, representatives from the Ministry of Education, and leaders of several national teachers' unions.

- On March 29 to 30, the GTD held an international seminar entitled “The Teaching Profession in Latin America: A Pending Agenda and Four Emerging Challenges” in Lima, Peru. The seminar, sponsored by the Ministry of Education and co-organized by PREAL and two other non-governmental organizations—Task (*Tarea*) and the Educational Forum (*Foro Educativo*)—sought to generate and exchange ideas on the teaching profession in Latin America.

Other Education Policy

- PREAL, in association with the government of Chile and the Inter-American Development Bank, hosted on July 10 and 11 in Santiago, Chile the International Seminar to Prevent School Violence. The seminar featured results from the Red Cross Youth of Colombia and *Caja de Compensación Familiar*

de Antioquia (CONFAMA) programs, the International Children's Defense of Ecuador, the Educational Development Foundation of Brazil, and the Human Rights and Popular Education Center of Brazil. At the seminar, PREAL launched its new publication *Tools to Prevent Violence in Schools (Herramientas para Prevenir la Violencia en las Escuelas)*.

- PREAL and Learn First (*Primero Aprendo*)—a joint project of CARE, Catholic Relief Services, and DevTech—officially launched the book *Educational Policy for Child Workers: Towards the Eradication of Child Labor in Central America and the Dominican Republic* in Panama City on August 8. The book—which includes policy recommendations as well as synopses of the national case studies done in El Salvador, Nicaragua, Dominican Republic, Guatemala, Costa Rica, and Honduras—promotes a regional agenda centered on offering more and better education opportunities for working children.
- PREAL teamed up with its Honduran partner FEREMA to present the national

report, “Educational Choices for the Working Children in Honduras” in Honduras on June 19th.

- On March 20 to 21, PREAL and *Primero Aprendo* held a two-day international workshop on child labor in Guatemala. The event convened some 35 civil society and government leaders from six Central American countries, including the Dominican Republic.
- PREAL, in cooperation with the Inter-American Development Bank, held the closing workshop for its Institutional and Managerial Capacity Development Program for Central American Education Ministries (Coaching) project in Panama City on June 14th. The workshop was part of the IDB’s Regional Policy Dialogue for Central America, a forum that periodically brings together the region’s education vice ministers to discuss strategic topics in education reform.
- PREAL, the IDEA Foundation (*Fundación IDEA*), and Mexicans First (*Mexicanos Primeros*) co-organized the international seminar “Accountability: An Opportunity for Quality Education” on June 5 and 6 in Mexico City. Mexico’s secretary of public education inaugurated the event, along with PREAL’s co-director, the executive director of *Fundación IDEA*, and a representative of *Mexicanos Primeros*.
- “What can be done about Latin America’s failing public schools?” was the focus of a Dialogue roundtable featuring Emiliana Vegas, co-author, *Raising Student Learning in Latin America: The Challenge for the 21st Century* on December 7.

COUNTRIES AND SUBREGIONS

Andean Region

Andean Working Group

The Dialogue held the thirteenth meeting of the Andean Working Group in Bogotá, Colombia on December 3 and 4, 2007. Participants engaged in a lively discussion of each of the countries in the region—Peru, Bolivia, Ecuador, Colombia, and Venezuela—as well as the region's cooperation with the United States, Canada and Europe. The meeting came during an especially active time, overlapping with the constitutional reform referendum in Venezuela, the controversial preliminary approval of a draft constitution in Bolivia, the start of the constitutional assembly in Ecuador, the passage of a free trade agreement between the United States and Peru, the release of proofs of life for high-profile hostages held by the FARC in Colombia, and tensions between Colombia and Venezuela over the involvement of President Chávez in the humanitarian exchange negotiation process. Participants addressed these topics and many others, but a few broad regional governance trends stood out, including clientelism, personalism, presidential succession problems, reelection, constitutional assemblies, and weak foreign ministries.

The twelfth meeting of the Andean Working Group was held in Washington on May 7 and 8. Participants discussed each of the countries in the region—Peru, Bolivia, Ecuador, Colombia, and Venezuela—as well as the growing influence of Brazil and the United States. The meeting came on the heels of President Álvaro Uribe's visit to Washington, which he used to push for the approval of the free trade agreement between the U.S. and Colombia, the renewal of Plan Colombia funding, and the unfreezing of aid money. Emphasis was placed on the U.S. free trade agreements with Peru and Colombia, the possible

extension of the Andean Trade Preferences and Drug Eradication Act, and Colombia's para-politics scandal—revelations that high-level legislators and government officials, primarily supporters of President Uribe, collaborated with paramilitary leaders. Other themes that emerged during the meeting included the political consequences of drug trafficking, energy integration, and fractured party systems in the Andean countries.

Other Andean Region

- At a special public session hosted by the Friedrich Ebert Stiftung Foundation in Bogotá following the Andean Working Group meeting, participants Michael Shifter and Alexandra Guáqueta offered a brief overview of the conclusions of the meeting before Eduardo Gamarra and Adrian Bonilla gave an update on the drug and security policies in Bolivia and Ecuador, respectively.
- Instituto de Defensa Legal, a Peruvian NGO, sponsored a public event in Lima on March 26 for Michael Shifter to present the Spanish translation of the Chávez report and engage in an exchange with the participants. The audience was a high-quality and diverse group of government officials, academics, and members of the policy community.
- The Dialogue hosted a public discussion about the Unsettled Andes: Current Economic and Political Issues on March 14 featuring Marcelo Guigale, director for the Andean region at the World Bank and Patrick Esteruelas of the Eurasia Group.

Colombia

- Violence, Democracy, and Press Freedom in Mexico and Colombia was the focus of an October 23 discussion featuring comments by Enrique Santos Calderón, editor of *El Tiempo* (Colombia) and Mariclaire Acosta with the Organization of American States.
- Hollman Morris, Colombian investigative journalist and documentary filmmaker spoke on challenges to press freedom in Colombia on October 30, 2007. Congresswoman Jan Schakowsky (D-IL) participated in the discussions.
- Human Rights and the Justice System in Colombia were the focus of an October 9th discussion featuring two high-ranking officials from the office of the attorney general of Colombia, Luis González, director of the Peace and Justice Unit, and Sandra Castro, director of the Human Rights Unit.
- Colombia's minister of defense, Juan Manuel Santos headlined an October 18 breakfast discussion on his country's evolving relations with the United States. He spoke of the U.S. Congress' failure to ratify a free trade agreement with Colombia despite security gains under Plan Colombia.
- On September 17, Juan Manuel Santos, minister of defense of Colombia met with nine member of the U.S. Congress for a dinner discussion on U.S.-Colombia Relations. The meeting was convened in anticipation of a review and renewal of funding for Plan Colombia and in the context of the debate regarding consideration of the U.S.-Colombia free trade agreement.
- Eduardo Pizarro, president of the National Reparation and Reconciliation Commission of Colombia led a discussion on July 18 on the Colombian government's struggle to negotiate a sustainable peace with rebel groups

while at the same time ensuring that human rights violators are brought to justice and that the victims of the internal conflict receive adequate reparations. The July 18th roundtable highlighted the enormous challenges faced by Colombians trying to strike this delicate balance.

- Sergio Fajardo, mayor of Medellín, addressed a public session at the Dialogue on July 9 outlining his successful strategy for overcoming the challenges of running what was at one time one of the most violent cities of the world. He is credited with redefining local politics in Colombia, witnessed by his 90 percent approval rating.
- Co-hosted by the Dialogue, Vice President Francisco Santos of Colombia spoke on May 24 at the Carnegie Center for International Peace, highlighting Colombia's economic growth in the face of the para-politics scandal.
- The Dialogue presented a public symposium, "Understanding Colombia's Para-Politics Scandal: Domestic and International Implications," on May 8, featuring Antonio Navarro, general secretary of the *Polo Democrático Alternativo*; Rafael Nieto, columnist

for *Semana*; Rafael Pardo of the Liberal Party's National Leadership Board; Rodrigo Pardo, editor of *Semana*; and Marta Lucía Ramírez, senator from *Partido de la U*.

- On March 8, former M-19 guerrilla Gustavo Petro, now a widely respected Colombian senator from the opposition party *Polo Democrático Alternativo*—recognized for his key role in uncovering the current paramilitary scandal in Colombian politics—offered his perspective on the ongoing investigations and Colombian politics more broadly.
- In cooperation with the Initiative for Inclusive Security, the Dialogue hosted a discussion on the participation of women in the Colombian peace process led by Isabel Londoño of the Foundation of Women for Colombia and Alicia Eugenia Silva Nigrinis of the Cultural Promotion Fund of Bogotá on January 18.

Venezuela

- At a Dialogue roundtable on October 1, Germán Mundaraín, ombudsman of the Bolivarian Republic of Venezuela, defended the constitutional reforms presented by President Hugo Chávez that passed preliminary votes in the National Assembly and were headed for a popular referendum. He addressed the major controversies over the reforms, which would allow for indefinite presidential reelection, change the classification of private property, and distribute social benefits to workers in the informal sector.
- Leopoldo López, mayor of Chacao municipality of Caracas, spoke on the current status of crime and justice in Venezuela and proposals for reform on June 21 at the Dialogue.
- The Center for Hemispheric Policy at the University of Miami invited Michael Shifter to present his report on Chávez at a public event they organized on March 29. Peter Hakim and Susan Purcell, the director of the Center for Hemispheric Policy, offered commentary and Shifter answered questions from participants, who included David Adams, Latin America Correspondent for the *St.*

Petersburg Times; Carl Cira, director of the Summit of the Americas Center at Florida International University; and Tim Padgett, Latin America bureau chief at *Time* magazine.

- Michael Shifter, the Dialogue's vice president for policy, met with the Congressional Members Working Group on March 13 to discuss the highlights of his recently-published report, *Hugo Chávez: A Test for U.S. Policy*, and reflect on the outcomes of President Bush's recent trip to Latin America. He briefed congressional staff on the same issues the day before.
- The Dialogue released *Hugo Chávez: A Test for U.S. Policy* on March 8. The report says the relationship with Venezuela poses a major challenge for U.S. policy in the hemisphere, but Washington has shown little skill or consistency when dealing with Hugo Chávez as he moves to polarize the region and disrupt the U.S. agenda. The monograph by Michael Shifter, vice-president for policy at the Dialogue, offers ten guidelines to help U.S. government officials formulate a more coherent approach to the complex Venezuelan situation and build a more effective presence in the region.

Dominican Republic

- Co-hosted by the Dialogue on September 18, President Leonel Fernández of the Dominican Republic spoke at the Center for Strategic and International Studies on constitutional reform in his country. The redefinition of Dominican nationality—changes that would alter the historic patterns of granting Dominican citizenship—has ignited controversy among Dominicans and Dominican-Americans alike. Roberto Alvarez, the permanent representative of the Dominican Republic to the OAS, moderated the discussion and introduced Ambassador Flavio Dario Espinal, the Dominican ambassador to the United States and one of thirteen jurists who developed the new constitution. As an independent observer on the panel, academic Rosario Espinal offered an evaluation of the proposed reforms. Secretary General of the OAS José Miguel Insulza and Claudio Grossman, professor and dean of the Washington College of Law at American University, commented.
- The second Dialogues on Democracy workshop was held in the Dominican Republic in October (see page 17).
- President Leonel Fernández of the Dominican Republic; Rep. Mike Honda (D-CA); Rep. Jim Moran (D-VA); Mack McLarty, president of Kissinger McLarty Associates presented the findings and recommendations from the *Report Card on Education in Central America and the Dominican Republic: A Lot to Do*, just released by the Dialogue's education program—the Partnership for Educational Revitalization in the Americas (PREAL) on September 19.

Puerto Rico

- At the crux of the complicated issue of Puerto Rico's status is the constitutionality of the current arrangement, agreed speakers at a June 11 Inter-American Dialogue discussion. Dialogue member Maurice Ferré, former mayor of Miami, was joined by Jeffrey Farrow, President Clinton's advisor on Puerto Rico, and Christina Duffy Burnett, professor of Constitutional law at Columbia University Law School.
- On March 27, the Dialogue hosted a roundtable discussion on the multiple challenges confronting Puerto Rico today and how the continuing impasse of the island's political status might be addressed. Prominent Radio host Angel Collado-Schwarz, the president of the Fundación Voz del Centro and chairman of the University of Puerto Rico Press led off the discussion, and University of Puerto Rico law professor and constitutional expert, José Julián Alvarez offered commentary.

Central America

- Guatemalan vice president Eduardo Stein led a November 20th discussion on challenges facing President-elect Álvaro Colom, with commentary by Hugo Beteta, secretary of the Inter-American Development Bank; Carolina Roca, superintendent of the Tributary Administration of Guatemala (SAT); and Raquel Zelaya, executive director of the Association for Social Studies and Research (ASIES).

- Eduardo Stein also spoke at the Dialogue on September 20 about Guatemala's presidential runoff election on November 4. Álvaro Colom of the Unidad Nacional de la Esperanza party and Otto Pérez Molina of the Partido Popular each received roughly 30 percent of the vote in the first round.
- In anticipation of Guatemala's upcoming elections, on May 23 Eduardo Stein again presented his views on recent developments in Guatemala. Topics included challenges to Guatemala's security and prosperity, the optimal pathway to political reform, and the political climate in Washington regarding the Central American state. He also spoke at an informal breakfast on February 13.
- Álvaro Colom, the leading candidate for Guatemala's September presidential elections, spoke about his inclusive electoral strategy and the content of his political platform at a June 27th meeting at the Dialogue.
- The Dialogue hosted the first in a series of Guatemalan presidential candidate forums on June 22. Retired General Otto Pérez Molina candidate for the Partido Patriota, at the time second in the polls, presented his platform of *mano dura* security strategies and plans for deepening democracy.
- The first Dialogues on Democracy workshop was held in Guatemala in March. (See page 17.)
- The state of politics in El Salvador and the elections of 2009 were the topic of a conversation at the Dialogue on November 8 featuring Alberto Arene, president of the Frente Democrático Revolucionario, and Arturo Zablah, presidential candidate for the Alliance for Change coalition.
- The Dialogue hosted on September 28 a conversation with former candidate for vice president Epsy Campbell Barr, president of Costa Rica's Citizen Action Party, on the CAFTA-Dominican Republic referendum in Costa Rica.
- Former presidential candidate Ottón Solís of Costa Rica's Citizens Action Party and Ambassador René León of El Salvador led a discussion on CAFTA, Democracy, and Development in Costa Rica and the Region on January 25. The session was co-sponsored by the Inter-American Dialogue, the Center for Global Development, Oxfam, and Action Aid.
- "Can Aid Work in Politically Changing Environments? The Achievements and Pending Challenges of the Millennium Challenge Corporation (MCC) in Central America" was the topic of an October 2nd roundtable discussion at MCC Headquarters in Washington. - In November the Dialogue launched the Miami Group on Western Hemisphere Affairs, a forum that regularly assembles the city’s corporate and financial leadership to exchange ideas with U.S. and Latin American policymakers on the most important issues affecting business and trade in the Americas. The Miami Group’s first meeting featured Mexico’s finance minister, Agustín Carstens.
- The Dialogue hosted a discussion with Rafael Fernandez de Castro of ITAM on November 16 on Mexican foreign relations under President Felipe Calderón. Rep. Chris Cannon (R-UT) joined the discussion.
- Violence, democracy, and press freedom in Mexico and Colombia were the topics of an October 23rd discussion led by Enrique Santos Calderón, editor of *El Tiempo* (Colombia), and Mariclaire Acosta, Universal Civil Identity Program in the Americas, OAS.
- The Dialogue hosted Deputy Assistant Secretary of Defense for Western Hemisphere Affairs Stephen Johnson on October 16. The planned \$1.5 billion security cooperation partnership with Mexico was an important part of his presentation, and received considerable media attention.
- The Dialogue hosted a roundtable discussion on the first six months of Felipe Calderón’s administration on July 10, featuring Jonathan Davis and Carlos Hurtado of the Inter-American Development Bank, and Gray Newman of Morgan Stanley.
- Together with the Woodrow Wilson Center, the Dialogue hosted a welcoming reception on March 27 for Mexican Ambassador Arturo Sarukhan. Senator Ken Salazar was the keynote speaker. Also that evening, the Dialogue and the Wilson Center organized a small dinner for the ambassador.
- Patricia Espinosa Cantellano, secretary of foreign affairs of Mexico under President Felipe Calderón, spoke about the new administration’s policy priorities for U.S.-Mexican relations at a February 27th event co-sponsored by the Dialogue with the Center for Strategic and International Studies and the Woodrow Wilson International Center for Scholars, at CSIS.

CORPORATE PROGRAM

The Dialogue's Corporate Circle continued to expand in 2007, with companies like Dell, Embraer, Prudential and Procter & Gamble joining the group, among dozens of others. The Circle attracted an all-time high number of companies, surpassing 135 members.

In November the Dialogue launched the Miami Group on Western Hemisphere Affairs, a forum that regularly assembles the city's corporate and financial leadership to exchange ideas with U.S. and Latin American policymakers on the most important issues affecting business and trade in the Americas. The Miami Group's first meeting featured Mexico's finance minister, Agustín Carstens, with sessions in 2008 planned with Brazil's Central Bank president, Henrique Meirelles, and Andean Development Corporation (CAF) President Enrique García.

In partnership with the Canadian Foundation for the Americas (FOCAL), the Dialogue in 2007 began bringing Canadian companies invested in Latin America and the Caribbean into our events and activities. Scotiabank and Xela Enterprises were among the Canadian companies becoming active with the Dialogue.

The Corporate Circle's *Advisor* newsletters added new executives to their Advisory Boards in 2007. General Motors economist Alejandro Delgado and former U.S. diplomat John Maisto, now a director of the U.S. Education Finance Group, joined the

Board of the daily *Latin America Advisor*. Washington attorneys Jonathan Hamilton and Raul Herrera now serve on the Board of the Dialogue's weekly *Energy Advisor*, while Jeanne Del Casino of Moody's Investors Service is part of the biweekly *Financial Services Advisor*. The Q&A section of the *Advisor* newsletters responded to more than 300 questions in 2007, many submitted by subscribing member companies. The Dialogue's *Advisor* also launched a new subscription-based web service, www.latinoutlook.net, jointly with Miami-based *Latin Business Chronicle*.

In the summer of 2007, the Corporate Circle began conducting polls with Zogby International. The joint Dialogue/Zogby polls report on U.S. public views of Latin America—and have generated widespread media attention. The Dialogue was named one of the top 25 most-cited think tanks in the United States media last year by an independent watchdog group.

The Dialogue secured a \$75,000 grant from the Ford Foundation to strengthen and expand its corporate sector engagement. John McCarter—a Dialogue member and former CEO for G.E. Latin America—agreed to serve as the lead consultant on the project.

Corporate Circle members met with senior Dialogue staff in private briefings throughout the year, and numerous Circle members spoke at Dialogue events (see the Trade and Economics section for a full listing).
